EUROPEAN UNION RELOCATION PROGRAM

And travel to a European country without
paying any money!!!

If you entered Greece after the 16th of September 2015, you are a citizen of Syria, Iraq, Eritrea, Central African Republic, Yemen, Bahrain, Swaziland, or a stateless person who used to live for many years in these countries, then most possibly you are in need of international protection and Greece will propose your participation in the European Union relocation program.

What does this mean?

- 1) Greece will request another European Union country to take over the examination of your case.
- 2) As soon as we are informed by the other country that you and your family members (wife and children) are accepted, we are going to ensure that you will be transported there safely and free of charge within two months.
- 3) As soon as you arrive in the other country, it will take over the examination of your asylum application and will attend to cover your basic material needs.

However:

Because you are in need of international protection, you must first lodge an asylum application in Greece and have your fingerprints taken.

Attention!

- If you have relatives in another European Union country, you have to report that.
- **You cannot choose the European Union country in which you will be relocated,** however factors such as having relatives, having lived, worked or studied in a European Union country as well as the condition of your health are taken into account.
- You must hand over any documents you have that verify your identity, as well as any documents provided to you by the Greek Police.
- The truthfulness of your statements and the authenticity of the documents you present is going to be checked by the Asylum service and by specialists from European countries .

It is towards your own benefit to tell the truth when answering the questions asked.

- If you depart without the appropriate documents and go to another European Union country before the relocation procedure is completed, you will be returned to Greece.



- After being recognized as a refugee by a European Union country, you will have to remain in that country.
- You are not allowed to leave from the country you will be transferred to, unless you are given permission by the Authorities.
- If you leave without permission, you are going to be returned to the country where you were recognized and where your provided rights apply.

Do not give your money to smugglers and do not put yourself and your family in danger and discomfort. Participate in the European Union relocation program and we are going to take care of your safe transport within 2 months.

In order to participate in the European Union country relocation program:

- **Notify a UNHCR or EASO representative that you are interested in the relocation program, or**
- **Go to a Regional Asylum Office of the Asylum Service, or**
- **Call through Skype, user ID: asylum.service.relocation every Monday, Tuesday and Wednesday, 9:00a.m. to 10:00a.m. to book an appointment for your application.**
